PA20/00612 Rear kitchen/utility room extension. 14 Chynowen Parc Cubert Newquay Cornwall TR8 5HD for Mr And Mrs Pearce - **Approved**

PA19/09513 Demolish existing flat roof garage and store. Form new extension, forms studio, wc and utility room. New part pitch over in natural grey slate.
